WHEREAS, the Governing Board of the Hardee County Indigent Healthcare Special District Board of Hardee County, Florida on September 5, 2017, adopted Fiscal Year 2017-2018 Tentative Millage Rates following a public hearing as required by Florida Statute 200.065

WHEREAS, the Governing Board of the Hardee County Indigent Healthcare Special District Board of Hardee County, Florida held a public hearing as required by Florida Statute 200.065; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Hardee County, has been certified by the Hardee County Property Appraiser to the Governing Board of the Hardee County Indigent Healthcare Special District Board as \$1,552,709,350.

NOW, THEREFORE, BE IT RESOLVED by the Governing Board of the Hardee Indigent Healthcare Special District Board of Hardee County, Florida that:

Section 1. The Fiscal Year 2017-2018 operating millage rate is 0.3542 mills, which is greater than the rolled back rate of 0.0000 mills by 100%.

Section 2. This resolution will take effect immediately upon its adoption.


